The official technical meetings are scheduled for three venues as follows:

Men's competition:

- January 3, 2024, in Zagreb, starting at 19:00h local time (CET) at Aristos Hotel.
- January 3, 2024, in Dubrovnik, starting at 19:00h local time (CET) at President Hotel.

Women's competition:

• January 4, 2024, in Eindhoven, starting at 19:00h local time (CET) at Van de Valk Hotel Eindhoven.

<u>Please be aware that all appointed Delegates and Referees must arrive no later than</u> <u>13:00h CET on the day of the Technical Meeting.</u>

The workshops for Delegates and Referees during the European Water Polo Championships in Croatia and the Netherlands will take place in the same venues/hotels straight after the Technical Meetings.

Please take note that the **<u>organizing Federation (LOC)</u>** is financially responsible for the accommodation (excluding extras) on a full board basis for:

- European Aquatics Delegates from 03rd to 16th/17th January 2024, for men's competition.
- **European Aquatics Delegates** from 04th to 14th January 2024, for women's competition.
- Neutral referees from 03rd to 16th/17th January 2024, for men's competition.
- **Neutral referees** from 04th to 14th January 2024, for women's competition.

Furthermore, the organizing Federation (LOC) has to provide transport from the nearest airport to the official hotels and back, and from official hotels to the competition venue and return, for Delegates and the listed Referees according to European Aquatics EWPC Rule EC-WP 7.1

The Federations of the nominated Referees are financially liable for:

• The travel to Zagreb, Dubrovnik (CRO), or Eindhoven (NED) and back, accommodation, and 100-€ daily allowance (per diem) for their Referees according to European Aquatics Regulations.



European Aquatics shall be financially responsible for:

- The travel to Zagreb, Dubrovnik (CRO), or Eindhoven (NED) and back for the Delegates
- The travels to Zagreb, Dubrovnik (CRO), or Eindhoven (NED) and back, for the Neutral Referees
- Daily allowance of 100-€ daily for each day of stay including travel days for the delegates and neutral referees
